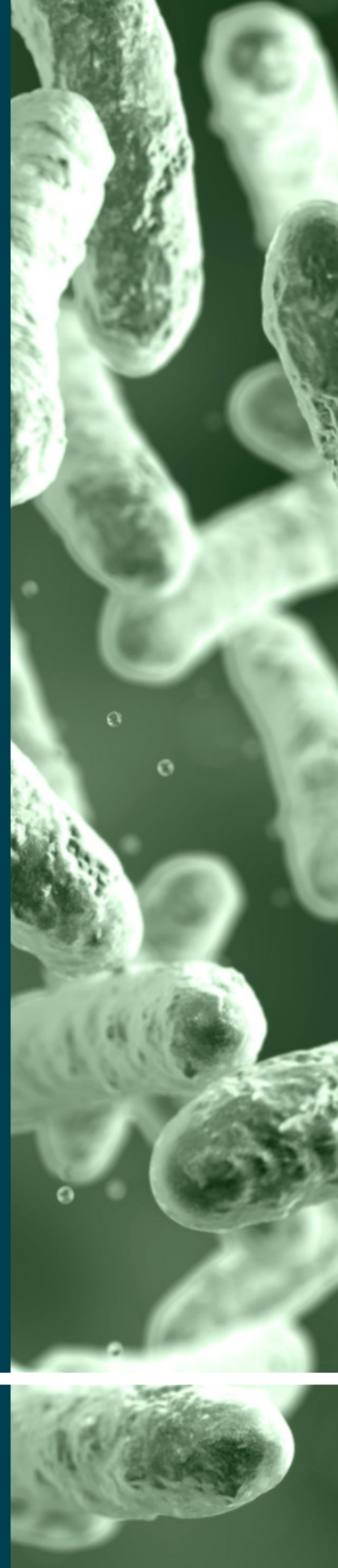

Remedial Work can be derived from the Legionella Risk Assessment or routine Planned Preventative Maintenance (PPM) work and will be prioritised based on the Risk Profile or we can provide a quote to you as an independent contractor to your main Water Hygiene service provider.

Risk Assessments

We can help you identify and understand any potential risks of Legionella and help you implement measures to either eliminate or control the risk.

Our Risk Assessment Services

The Risk Assessment, being the cornerstone of a legionella compliance program, is the basis of a control scheme. Where this is not available or out of date, a site survey would be carried out and a Legionella Risk Assessment, aligned with ACOP L8, HSG274 Parts 1-3 and BS8580 would be created.

Our independent Risk Assessors are trained to a high standard and provided with a document library of Method Statements, Task Risk Assessments and COSHH Assessments, which are maintained and kept up to date by our Compliance Manager, these include information from the relevant guidance as well as the LCA's 'Standards for Service Delivery'. Legionella Risk Assessments are further audited by a qualified member of the compliance team to ensure it meets the high standards we expect to deliver and covers all the requirements of BS8580 and HSG274 Parts 1-3.

Sampling

Samples are electronically tracked from the time they are taken through to the sample result and customers are automatically notified of any out of parameter findings.

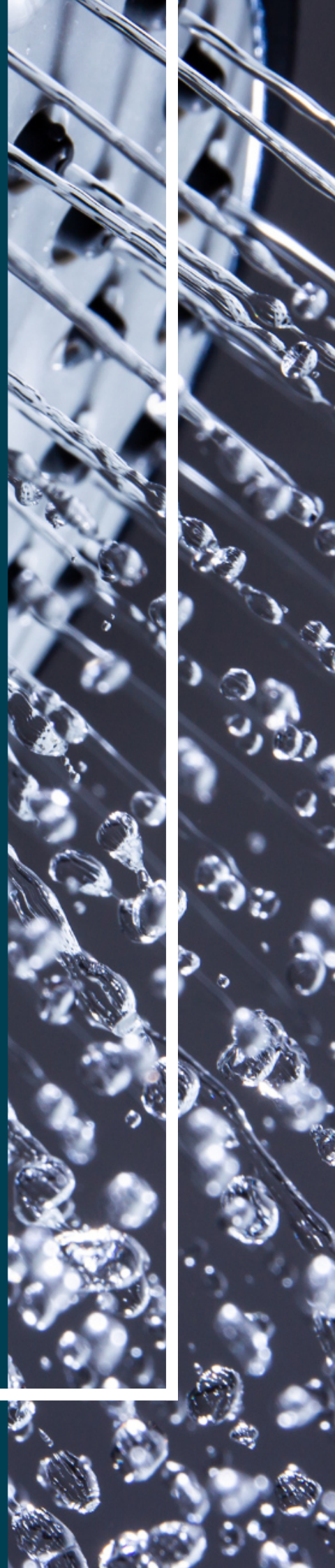
